# Green Life Group:

▶ The initial development of Green Up eco-products occurred between 2003 and 2009. In 2010-2011 the company ran a marketing pilot in Israel to determine the suitability of the products for the needs of the market. Today the company's activities include production, marketing and customer support to clients in Israel and abroad. The products are tested by regulatory agencies and copies of some of these tests and results are included with this presentation.

# Agriculture Industry

Agriculture today uses a variety of pesticides, many of which are poisonous and dangerous to human health. In light of the reforms and changes which are happening in agriculture, especially with field crops and in packing areas, there arose a need for new cleaning and disinfecting ecological products.





# Green Up F&V -The Green Solution

- Green Up F&V is superior in its ability to dissolve and remove oils in a variety of fatty acids and effectively achieve anti-bacterial cleaning of a wide range of micro-organisms including Gram positive/negative bacteria, pathogenic food related bacteria, yeasts and microscopic fungi.
- Green Up F&V is not flammable and does not emit poisonous gases or synthetic smells which are typical of chemical cleaning agents.



**Green Up F&V** provides solutions in the packing house for many operations such as fogging, drenching, cleaning and disinfecting containers and prolonging the shelf life of fruits and vegetables.







- Most of the fruit and vegetable export packing facilities in Israel use Green Up F&V.
- Examples of these are avocado, orange, mango, carrot and sweet pepper among others.

- 2. Spraying the fruits/plants during the growing period.











- One example is cleaning the heat exchanger with Green Up instead of strong and harmful chemicals.



Conclusions: According to Israeli Standard 1944 (1997) the product possesses antimicrobial activity and demonstrate 99.99% reduction in the bacterial viable counts and conforms to the requirements of the Israeli standard 1944.
